Cultivator, Independent Marijuana Testing Laboratory, Marijuana Product Manufacturer,

Marijuana Research Facility and Marijuana Transporter, where a special permit shall be required by the Planning Board in accordance with MCC 12.12.020;";

-Section 12.12.190, first paragraph, by striking "City Council" and replacing with "Planning Board" as follows: "A Marijuana Establishment, as defined by this Ordinance

to expressly only include Marijuana Retailer, Marijuana Cultivator, Independent Marijuana

Testing Laboratory, Marijuana Product Manufacturer, Marijuana Research Facility and

Marijuana Transporter, may be allowed only in the Highway Business, Industrial 1 and

Industrial 2 zoning districts or the Marijuana Establishment Overlay District, only by special

permit granted by the Planning Board and only in conformance with the following controls  $% \left( 1\right) =\left( 1\right) \left( 1\right)$ 

and requirements:";

-Section 12.12.190.B, Section 12.12.190.G, Section 12.12.190.G.4, Section 12.12.190H,

by deleting "City Council" where written and replacing with "Planning Board";

-Section 12.28.010.E, by deleting "City Council" where mentioned and replacing

with

"Planning Board"

Councillor Sica, the sponsor of the paper stated that the first 3 licenses that were issues there was very little political influence. because of one applicant there is political influence."I will be a witness in court". We put this paper on the docket tonight so we all can't be corrupt. The Planning Board issues special permits, we tried to do this in 2019.

Councillor Crowe offered a friendly amendment that it could be the Planning Board or CLEC to issue the Special Permit. Councillor Sica responded that CLEC didn't want to do it, it had to be the Planning Board or City Council.

Councillor Simonelli said he never felt granting the Special Permits should be with the Council, he would prefer CLEC but supports it going to the Planning Board.

## 288-22 Resolve: That the Malden City Council celebrates LGBTQ Pride Month

WHEREAS, lesbian, gay, bisexual, transgender/nonbinary, and queer (LGBTQ) people in Malden make vital contributions to all areas of business, public service, culture and community life, and

WHEREAS, the celebration of Pride Month each June is rooted in the protests of June 28, 1969, following a law enforcement raid of the Stonewall Inn, an LGBTQ club in New York City, as a pioneering moment in the LGBTQ movement for equality; and

WHEREAS, throughout much of the history of the United States,

non-heteronormative relationships gender identities criminalized; **LGBTQ** and were people continue to face disparities in employment, healthcare, education, and many other areas; and many states have enacted new anti-LGBTQ legislation in the past few months, and

WHEREAS. LGBTO people, particularly those who are transgender/nonbinary and Black, Indigenous and People of Color disproportionately high (BIPOC), face a risk of becoming victims of violent hate crimes; and

WHEREAS. LGBTQ youth are at increased risk of bullying, mental health concerns, homelessness, and suicide; and

WHEREAS. Pride celebration the full is а of spectrum of humanity, creative expression, and visibility in spite of marginalization, which is hosted by thousands of communities each year across the globe;

NOW, THEREFORE BE IT RESOLVED, that the Malden City Council supports the rights, freedoms and equal treatment of LGBTQ people, affirms the importance of welcoming community for all, and encourages the celebration of June as Pride Month" to honor the contributions, struggles and dignity of LGBTQ members of our community.

Councillor McDonald made a motion to recess at 7:11 P.M.for the flag raising ceremony. It was so voted 11-0.

Councillor O'Malley said that we may have another chance to look at where the building is being moved too once the building is accepted by public properties.

Councillor Winslow said we should be working with the schools on the moving of the building.

Councillor Linehan stated she was glad to bring in the voices of the community and she will put in her council funds as well to move the garden.

Councillor Condon said the building will fit in with the surrounding building, its a historical corridor.

Council President Spadafora said before final approval of the move the public properties should have a final look.

City Planner Romero stated that she along with Building Commission Miller are currently in discussions on the building move.

Committee Report: The Standing Committee on Parking Review having considered Paper 294-22 make the following report that the Committee recommends this resolve be reported out favorably to the Full Council.

294-22 Resolve: That it is the sense of the Malden City Council that the traffic regulations be updated with the addition of the following sections.

#### Addition of Section 5.10(A)

Vehicles to be Registered in Malden

Persons becoming residents of Malden having relocated from out of state or within state are required to register their vehicle to their Malden address. No vehicle bearing out of state plates or vehicle registered to or principally garaged in another

city or town in Massachusetts shall be permitted to park on any City Street or combination of City Streets more than 4 times over a 30-day period.

Enforcement of the above regulation shall take place from Sunday to Thursday between 10 pm and 6 am, provided that an initial one time 14-day grace period shall apply to each vehicle.

The Parking Department may issue a Monthly Visitor Parking Permit to those requiring the ability to park on city streets for more than the time permitted by this regulation. Passes issued shall only be valid for parking in the immediate vicinity of the address of the permit holder. Monthly Visitor Passes will not be issued as a substitute for a resident properly registering their vehicle in Malden. Each permit shall contain the registration number of the vehicles to which it was issued.

The Parking Department may issue a Monthly Visitor Parking Permit to those Residents who have submitted the following documentation:

- 1. A completed application in a form determined by the Parking Department;
- 2. A copy of the applicant's driver's license with an address within the city;
- 3. A copy of a valid vehicle registration for the vehicle for which application is made.

Monthly Visitor Parking Permits shall expire 30 days from the date of issuance. The fee for a Monthly Visitor Parking Permit shall be \$25.

Parking permits shall be provided to those residing in Malden who have vehicle(s) registered outside of Malden due to active military service or who are actively enrolled as a full-time student in college. Additionally, parking permits for caregivers shall be provided. Permits for military, students and caregivers shall be provided at no cost.

Parking Review Chair Condon thanked Ron Hogan for his guidance with the process. Chair Condon continued that the committee did try to implement a citywide parking permit program but it was too difficult for too many residents. This plan is a good compromise and gets tom the issue of nonresidents and out of state plates parking on the streets overnight. The plan has no affect to Malden residents who 's vehicles are currently registered in Malden. The Resolve would go to the Traffic Commission.

Councillor Crowe supports the paper and talked about how difficult the parking program in Everett is.

Councillor Colon-Hayes said that we tried to make this easy for the residents. This paper

will accomplish what it was intended to do.

Councillor O'Malley supports the paper and congratulated Chair Condon, it was a long hard battle.

Councillor Linehan thanked Chair Condon saying its simple and will work.

Councillor Winslow said he appreciates the work of the committee and the paper is a good balance and will work for the folks in ward 6.

Council President Spadafora said he appreciates the tenacity of Councillor Condon.

The entire council requested to be sponsors of the Resolve.

A motion was made by Condon, seconded by Councillor Crowe, that the Resolution be passed. The motion carried by a unanimous vote.

Order: That the Malden City Council evaluate and make changes, if necessary, to the Municipal Code of Malden (MCC) Title 6, Chapter 08, Section 100 (b) (3) which states, that the area controlled by the, business is of sufficient size to allow a. storage or display of no fewer than 15 cars in paved, lined and numbered spaces no smaller than 10'X20', and b. employee and customer parking of no fewer than 3 spaces, provided that one additional employee/customer parking space shall be required for each additional 20 spaces of for storage or display. All spaces shall be clearly lined, numbered and designated in yellow traffic paint as storage/display or employee/customer parking.

Councillor Sica talked about the issues in the past with Class II Dealers needing to have 10x20 parking spaces and in the Malden zoning ordinance for business the size is 9X18. This would bring both sections requirement to 9x18.

Finance Chair Murphy gave background on the COLA (Cost of Living Allowance) paper. The Finance Committee and Long Term Financial Planning Strategy Committee held a joint meeting regarding the paper.

The Malden Retirement Board voted in favor of increasing the COLA base from \$16,000 to \$18,000 and the council needed to approve. Chair Murphy stated although not unanimous, the joint committee recommends the council vote in favor of the increase.

Councillor Colon-Hayes stated although she voted against in committee because of some confusion she will be voting in favor of the paper on the floor.

Councillor McDonald said he voted against the paper in committee and would have voted for a smaller increase but the truth is inflation is terrible for our seniors and will vote in favor of the paper on the floor. Councillor McDonald further stated we have a commitment from CFO Ranaghan if the economy continues to change that we work through the issues.

Councillor O'Malley thankedCouncillor Murphy for docketing the item in committee and on the agenda and although the amount is nominal, about \$60 per retiree, there is a concern that when the total amount is aggregated it is around \$5,000,000. Councillor O'Malley stated it will be challenging if your fund is losing money.

Councillor Winslow state dhe appreciated the work of the Retirement Board and we are ahead of the game and have the capacity to handle the downturn in the economy.

Council President Spadafora stated he supports the paper and the 3% increase is less that Social Security recipients who received a 5.4 % increase.

A motion was made by Councillor Murphy, seconded by Councillor Sica, that the Order be adopted. The motion carried by the following vote:
