Before Council President Spadafora opened the public hearing, Moses Okokuro from National Grid spoke what the project was and Councillor Winslow, the ward councillor where the work was taking place said he met Mr. Okokuro at the site and the project is straight forward. It is at the intersection of Elwell and Loomis where most times a second pole is used as a stabilizer but in this case it was a tree that has partially been cut down. Councillor Winslow said he supports the petition.

Council President Spadafora opened the public hearing to anyone that wished to speak in favor of the project. There were no speakers in favor of the project. Council President Spadafora closed that portion of the meeting.

Council President Spadafora opened the public hearing to anyone that wished to speak against the petition. There were no speakers against speaking against. Council President did speak against granting the petition that night because of National Grids unresponsiveness to a triple pole on Pearl and Adams Street that has not been addressed for 7 years. Council President Spadafora continued that the council can never get National Grid to address these concerns until they have hearings on something else.

Councillor O'Malley said that he is not in favor of holding up the petition tonight but added that National Grid needs to find a way to resolve all these unresolved issues.

Councillor Simonelli said the issue with double poles have been going on for years and National Grid needs to fins a way to resolve the issue.

Councillor Murphy agreed with holding up granting the petition until the triple pole is resolved on Pearl Street. Councillor Murphy spoke about a live wire on Starbird Street that needs to be addressed.

Councillor Winslow made a motion to table for two weeks and Mr. Okokuro can come back with information on outstanding double/triple poles.

Councillor added that he has one double pole that comes to mind on the corner of Mountain Ave and Tremont Street.

Council President Spadafora said that Malden was the culprit at one time because they had a fire line on the poles but those have all been taken down. Council President Spadafora continued that he has a list of 100 double poles that he got from Fire Chief Sullivan and suggested councillors should get the same list.

Councillor Crowe asked Mr. Okokuro how the work was done on Commercial Street when the paper (#253-22) was tabled last May and never voted on.

Mr. Okokuro said he would bring the concerns back to National Grid and bring back answers in two weeks.

A motion was made by Councillor Winslow, seconded by Councillor Murphy, that the Petition be tabled for two weeks to allow National Grid to get answers to the triple pole on Pearl Street and double pole on Mountain Ave and Tremont Street,. The motion carried by a unanimous vote.

Council President Spadafora said he has been in contact with the mayor on the paper and the need for the paper to be passed.

Councillor Winslow stated that who is responsible to get rid of the markings is unclear and he would like the DPW Committee to be part of the discussion. Councillor Winslow made a motion to refer the paper to a joint Ordinance/DPW Committee meeting.

Councillor Crowe agreed with Councillor Winslow and said at the corner of Madison Street it looks like paint by numbers there is so many leftover markings.

A motion was made by Councillor Winslow, seconded by Councillor Crowe, that the Ordinance be referred to a joint Rules & Ordinance/DPW Committee meeting. The motion carried by a unanimous vote.

369-22 Order: That One Million Dollars (\$1,000,000) is appropriated to pay costs of reconstructing and making extraordinary repairs to the Central Business District Garage, including the payment of all costs incidental and related thereto, and to meet this appropriation, the Treasurer, with approval of the Mayor is authorized to borrow said amount under G.L. c. 44, §7(1) or any other enabling authority, and to issue bonds or notes of the City therefor.

Finance Chair Murphy stated this paper would be taken up immediately in Finance because the repairs cannot wait. The repairs are badly needed and if not done, it is a hazard to those that use the garage.

A motion was made by Councillor Murphy, seconded by Councillor Condon, that the Order be referred to the Finance Committee. The motion carried by a unanimous vote.

370-22 Order: That the sum of One Hundred Twenty Eight Thousand One Hundred Sixty Four Dollars and Seventy Five Cents (\$128,164.75) be and the same is hereby appropriated from the TNC Surcharge Municipal Distribution Account to cover the following expenses: Road milling and paving, utility structure adjustments, pedestrian signal upgrades, wheelchair ramp upgrades, and new crosswalk line striping with thermoplastic at the intersection of Summer Street and Clifton Street.

Chair Murphy explained the funds are coming from the money the city gets per ride from any rideshare company. In the past the funds have completed work for intersections in wards 2,4 and 5. This appropriation is for work that will be done at the intersections of Summer Street and Clifton Street. Councillor Linehan said she is thankful for these funds and the work being done will be taking place at critical intersection and is exactly what the TNC surcharge is supposed to be used for.

Councillor Winslow stated there have been great improvements at intersections funded through the TNC account.

A motion was made by Councillor Murphy, seconded by Councillor Condon, that the Order be referred to the Finance Committee. The motion carried by a unanimous vote.

Chair Murphy said that there is no rush on this funding so she will be referring the paper to Finance.

Council President Spadafora asked City Planner Romero, who is well familiar with the project if she would like to speak on the topic.

City Planner Romero said she was speaking as clerk of the Historical Commission. Ms. Romero told the Council the project is completed and is an excellent job. Ms. Romero continued that there was \$200,000 already granted for the project and there is a need for this additional funding because of issues that surfaced after the work started. Ms Romero said she is available for the Finance Committee if the paper gets referred.

A motion was made by Councillor Murphy, seconded by Councillor Condon, that the Order be referred to the Finance Committee. The motion carried by a unanimous vote.

372-22 Order: That the City Council empowers the City's Legal Department to investigate and answer the alleged Open Meeting Law Complaint filed by Lissette Alvarado from the Friends of Roosevelt Park on August 12, 2022 against the Malden City Council and Ward 6 Councillor Stephen Winslow.

Council President Spadafora said that there was an Open Meeting Law Violation filed against the Council and as they have done in the past, the Council will vote whether to allow the Legal Department to investigate and respond on their behalf.

Councillor Winslow said that he has talked to Attorney McNaught in August when the complaint was filed because it names him specifically on the alleged violation.

Councillor O'Malley agreed that the Legal Department should handle the Complaint. Councillor O'Malley continued that there have been legitimate complaints filed and some that are not. Councillor O'Malley said that Councillor Winslow has the right to organize community members for a particular issue and he would defer to Councillor Winslow who answers the Complaint.

Attorney McNaught was asked to come forward and told the Council he has met with Councillor Winslow and if the Council is going to give the Legal Department authority to answer the Complaint, he would be contacting council members individually.

Councillor McDonald asked Attorney McNaught if the Council could take a vote to give the Legal Department blanket authority to answer any complaints that are filed so they would not have to keep on voting something they always vote for, having the Legal Department answer the Complaint.

Attorney McNaught answered that they do have to go through the process and the Council could not grant blanket authority.

Councillor McDonald stated he would be happy to have it as a standard policy.

A motion was made by Councillor Simonelli, seconded by Councillor Murphy, that the Order be adopted. The motion carried by a unanimous vote.

373-22 Order: That the City Charter, and applicable City Ordinances, be amended to make the City Solicitor an elected position by (a) striking paragraph one of section 14 of the Malden City Charter, and (b) adding a new section 37 titled "City Solicitor" detailing the manner of election and a 6 year term of the City Solicitor.

Councillor O'Malley the sponsor of the paper began the discussion by stating there is no ulterior motives for the paper and that he believes there is nobody in the Solicitor's office residing in Malden and local control is important. The Law Department takes on cases that can be costly to the City making local control very important. Councillor O'Malley said that it is a political entity and it is a step removed from the people. Councillor O'Malley continued that the position is not always accountable to the entire City Council and the department needs to be more impartial and less political. Councillor O'Malley moved to send the paper to Ordinance and Committee.

Councillor Condon said he is not in favor of moving the paper to ordinance or moving on the paper at all. Councillor continued that the Solicitor's office rules for us and against us, Councillor Condon continued, the council votes for the Solicitor, because someone doesn't live in the City doesn't mean they aren't qualified.

Councillor Winslow added he doesn't understand how having the City Solicitor elected addresses the sponsor's concerns. Councillor Winslow further stated that the City Council is a difficult client for the Legal Department to serve, this is not the way to go. There are 11 Councillors, it's not an easy client.

Councillor Murphy said she is not in favor of the paper. Councillor Murphy stated it is the Council's job to find the best person for the position and that this is not the appropriate way to go.

Councillor Simonelli stated this is not the direction we should go in. It is difficult enough for the City Solicitor to be listening to 11 Councillors, never mind thousands of voters. Councillor Simonelli stated the system works as it is.

Councillor Linehan stated making the City Solicitor being an elected position would not get what the sponsor is looking for and not the right direction for the city.

Councillor McDonald said he does not support electing the City Solicitor for the reasons stated tonight. If there are some concerns Councillor O'Malley has, he would like them taken up in committee.

Councillor Crowe stated she is opposed to the paper.

Council President Spadafora said there is not one city or town in Massachusetts that elects their Solicitor. Council President Spadafora continued we don't always agree with the City Solicitor's opinion but their interests are aligned with the citizens of Malden. There is a reason why Massachusetts do not elect judges like other states, if the City Solicitor was elected they would be more political than judges being elected.

This Order was withdrawn by the sponsor Councillor O', Malley.

374-22 Order: That the City of Malden place a ballot question on the 2023 municipal ballot asking: "Should the City of Malden install an artificial turf field at Roosevelt Park by the Salemwood School?"

A "yes" vote would support artificial turf; a "no" vote would reject artificial turf and support a grass field.

Councillor O'Malley the sponsor of the paper stated artificial turf has caused a lot of debate in the community and asked how much contamination are we allowing on the site. Councillor O'Malley continued that he wouldn't want a city council, 20 years from now asking why didn't they clean up the site.

Councillor Colon-Hayes said she would like to see it go on a ballot, it may lose but we would see what people want.

Councillor Murphy said she is not in favor of the paper and that it was just another way of delaying the project.

Councillor Murphy continued that this is a good plan and the park is in desperate need for renovations. The project will allow the Salemwood School students to have recess and sport groups like soccer, Pop Warner and lacrosse the ability to use the field, the field has not been used for two years.

Councillor Winslow said there was a community meeting held the prior Thursday and the city put together an incredible team to answer questions. The more money we use to delay this project the less we will have for other parks. Councillor Winslow continued that you need to seize the moment and he is not in favor of taking more money and time delaying the project and that there has been enough public input on the project. Councillor Winslow added that there was nothing that came out of the Thursday meeting that would warrant dragging this on.

Councillor Colon-Hayes said she could have put a panel of lawyers together that would have said the opposite of what was said at the Thursday meeting.

Councillor McDonald said my comment is democracy is good and a lot of people are engaged on this issue, the worst option is an advisory election and you have the election and it doesn't resolve the issue. Councillor McDonald asked is a special election possible rather than waiting until the next election cycle.

Clerk Lucey answered, the question would have to be put on a municipal election cycle

which would be in 2023. Clerk Lucey added that the idea of a special election would need to have more thought put into it of what it would look like and also told the Council the last special election that was held was earlier in the year on the Voke building project and there was 2 % turnout and it was his belief you would be looking at the same kind of turnout. Although there is interest, the only people that would be voting are those committed to grass and the sport groups that would be using the field and favor artificial turf.

Councillor McDonald made a motion to amend the paper to: the city hold a special election on the question as soon as the City Clerk determines the earliest date possible.

Councillor Murphy said the idea of a special election is once again kicking the can down the road. Councillor Murphy continued we have had hearings, we have done outreach, we have knocked on doors in the neighborhood, we have beaten this topic to death. It is not turf vs grass for her but doing something positive for the community and that her and Councillor Winslow have been working on the project for years and she finds it disheartening that there is still push back to delay the project. Councillor Murphy ended with if you put grass on the field you will end up putting a fence up and She hopes other ward councillors do not get the same response from councillors opposing projects in their wards.

Councillor Winslow said that he has been working on this project with Councillor Murphy prior to him getting elected to the Council in 2018. We have been talking about this for 5 years and I have personally knocked on doors in the neighborhood. There is no need of a vote because the democratic process has already taken place with the both of them getting elected, then reelected in spite of opposition from the Roosevelt group. Councillor Winslow stated lets get on with it.

Councillor Linehan said it was a good meeting Thursday night and she was surprised to see this item on the docket and it was her opinion an election is not needed and would not tell how the city stands on the issue. The Council has already taken the vote on the funding, my kid has never had a recess, we need to do right by the kids.

Councillor Condon said he has never seen a project handled like this, both sides got their say, we need to move on and get it done. Callahan Park wasn't clean, two oil tanks were on the site. Councillor Condon complimented Councillors Murphy and Winslow for standing their ground.

Councillor Colon-Hayes said both sides are passionate and it should not be taken as personal.

Councillor McDonald said he has stated publicly he is for grass but asked Attorney McNaught if an election is a valid approach or is the question only advisory.

Councillor McDonald withdrew his earlier motion regarding holding a special election.

Councillor Crowe said they have been talking about turf at Salemwood since she got on the Council in 2011 and she didn't feel the question should be on the ballot.

Council President Spadafora stated we won't change either sides mind and this is the third time we have tried this, the first being under Mayor Howard but the figures couldn't work.

A motion was made by Councillor O'Malley, seconded by Councillor at Large Colon Hayes, that the Order be adopted. The motion failed by the following vote:

Yea: 2 - Colon Hayes and O'Malley

Nay: 8 - Murphy, McDonald, Simonelli, Spadafora, Crowe, Linehan, Condon and Winslow

Order that the City of Malden place a ballot question on the 2023 municipal ballot asking: "Should the Department of Elementary and Secondary Education revoke or not renew the charter of the Mystic Valley Regional Charter School?"
 A "yes" vote would support revoking or not renewing the school's charter; a "no" vote would support the renewal the school's charter.

Councillor O'Malley the sponsor of the paper said it was his opinion that Mystic Valley Charter School has received a lot of taxpayer money and has taken a lot from the community. Councillor O'Malley continued that we are constantly reading about trauma to minority students at the school because of their school policies and they are looking to expand into communities like Woburn and the state is coming down on them. The residents of Malden should be heard if they feel that MVRCS is a benefit to the community.

Councillor Condon said he doesn't support this at all and what do you do with the 600 Malden kids at the school, the Malden Public Schools have no room for them. The Charter School is not for everyone, but do away with the School is not feasible.

Councillor Winslow stated the Charter School is controversial and a good many people in Malden are concerned with their lack of accountability and transparency. Councillor Winslow said the best ways to address the concerns is through their renewal process. The worse things for a kid is to change schools, Councillor Winslow said he could not support the paper but could support holding the Charter School Board accountable.

Councillor McDonald said Councillor Winslow hit the nail on the head. There is a problem at the school but this is not the appropriate way to address it.

Councillor O'Malley said their Charter is good for 5 years, the state will have the election results for when the Charter is being renewed.

The motion failed for a lack of a second.

Resolve: That the Malden City Council Objects to Orange Line Closure Process The Malden City Council strongly objects the Massachusetts Bay Transit Authority's approach to closing the Orange Line for one month starting August 19, 2022. In Malden, home to two Orange Line stations, 40% of our residents do not own a car and depend on transit service. While we recognize and endorse the need to invest in the safety and performance of our transit system, the manner in which the MBTA made this decision has created great hardship for our community. Countless residents, especially those with the fewest financial resources, are struggling to get to work, make medical and court appointments, attend school, get childcare, or visit loved ones in need. Most concerning was the lack of advance information available in multiple languages, the timing of this closure at the start of the school year, and the fact that that our elected leaders, including our Mayor and state legislators, had to fight to get adequate shuttle bus and commuter rail coverage. In the future, as it makes decisions about maintenance closures, we call on the MBTA to do the following:

- Work directly with local community leaders to decide when closures will take place in a way that minimizes impact;
- 2. Provide information well in advance, in multiple languages, on how residents can navigate the closures; and
- Establish funding to reimburse local governments and agencies as well as individual residents for hardships and additional expenses created by these closures.

The sponsor Councillor McDonald stated we all know how terrible and unacceptable the MBTA closing was and the city pays millions of dollars a year for their 2 stations and were not consulted. Councillor McDonald continued that there will be future maintenance issues and Malden needs to be part of the process.

Councillor Colon-Hayes asked to be added as a sponsor.

Councillor Linehan thanked Councillor McDonald for the Resolve and that when you have a community like Malden with so many languages and not get the word out earlier, it's not acceptable. Councillor Linehan said we have to make our voices heard as elected officials.

Councillor Winslow thanked Councillor McDonald and the work done by the state delegation and Mayor.

Councillor Murphy said their was a lack of communication and asked that she be added as a sponsor.

The entire City Council was added as a sponsor.

A motion was made by Councillor at Large McDonald, seconded by Councillor Condon, that the Resolution be passed. The motion carried by a unanimous vote.
