Councillors,

As you know, I have been calling around to poll for availability for the purpose of holding a Council meeting on July 28. I have not been able to reach all of you directly but I have reached enough to know we have confirmed a quorum. The purpose of this meeting is to address the OML determination that was returned from the State yesterday afternoon, which is attached for your review.

In the meantime, the Legal Department has instructed me to inform you all that the Attorney General's Office has ordered all voice mails, text messages, emails, or other documented communications having to do with Jeff Donohue's appointment, and the discussions that ensued from that, are preserved and released on the public record. These **must not be destroyed** and I am requesting you to forward all communications to me so I may list the communications in the meeting minutes.

Per the attached determination, these communications must be released publicly within 45 days and such action must be certified with the AGO proving they were released as ordered. Agenda posting to follow on July 23 per our standard operating procedure.
