

PETITION FOR GRANT OF LOCATION

Notice having been given and public hearing held, as provided by law, that **CROWN CASTLE FIBER LLC** is hereby granted a location for and permission to **upgrade existing wireless facilities** in the public way or ways hereinafter referred to, as requested in petition of said company dated the 22nd day of April, 2024 and the 19th day of August, 2024.

Upgrades to include replacement of the existing shroud with a new shroud that is 69.50" x 22.73" x 21.45", minimal changes to the exterior shroud design, and upgrading the existing antenna to a 48" x 14.6 antenna.

The following are the public ways or part of ways along which the small cell wireless facilities above referred to may be upgraded:

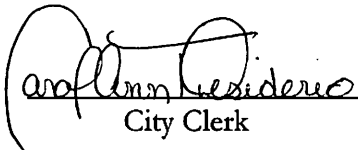

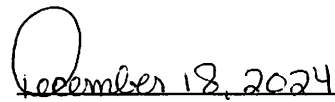

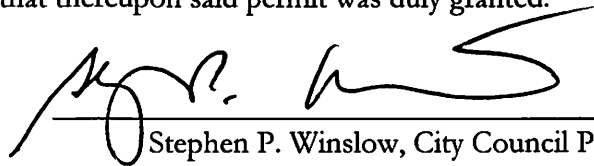
